

Alternative Response Initiative Workbook

The RFK National Resource Center is proud to announce the release of its new [Alternative Response Initiative Workbook](#). This publication, authored by John A. Tuell and Kari L. Harp, complements the RFK National Resource Center's Alternative Response Initiative (ARI), which supports state and local jurisdictions in their efforts to develop or enhance their system of alternative responses to formal prosecution.



The ARI Workbook presents a detailed set of tasks, activities, and timelines that adheres to the principles of effective technical assistance, with emphasis on the importance of multidisciplinary collaboration and the tenets of Implementation Science. The ARI's "Five Steps to Success" are explained in detail to help jurisdictions navigate through the preparation and formation of a collaborative leadership team, completion of an assessment and analytic process, formation of a detailed action strategy, implementation, and additional activities that lead to positive opportunities for enhanced practice within youth serving systems. This Workbook was thoughtfully developed for jurisdictions to use either independently or in partnership with external technical assistance.

Reform and State Courts Initiative, the RFK National Resource Center we will use its seminal four-phase Dual Status Youth (DSY) framework to provide training, technical assistance, and consultation in Delaware and among the family court, juvenile justice, child welfare, law enforcement, Attorney General's office (Family Division), and other relevant youth-serving organizations and agencies. This initiative will seek to positively impact outcomes for dual status youth, featuring a special emphasis on those youth who are at-risk of, or are the victims of, commercial sexual exploitation. Building on our prior experience, the enhancements and improvements in policy and routine practice realized through the work of this DSY-CSEC Initiative will focus on strengthening practices, programs, protocols, and services for a wide range of systems of care for these vulnerable and exploited youth. Following 60 days of intense preparation, our initial technical assistance site visit is scheduled for February 25-26, 2020.

Dual Status Youth Technical Assistance Initiative in Ohio

In July, we shared our announcement of the competitive selection of Ohio's Clark and Knox Counties to receive funding to support intensive Dual Status Youth technical assistance. The on-site partnership was launched this fall in both counties. Both jurisdictions have developed their respective Executive Multi-Disciplinary Committees and established additional subcommittees to provide tailored expertise and analysis on priority subject matters. These subcommittees are well on their way to informing the solutions that will establish sustainable, evidence-based policies and practices that positively impact dually-involved youth and their families. There has been significant early momentum and progress in both sites to define their target population, create methods to routinely identify the youth that will benefit from enhanced multi-system responses, innovatively propose coordinated practices across agencies and within the court, and begin construction of methods to collect, manage, and report the system performance and youth outcomes sought by this endeavor. These dedicated professionals are on the path to create unique and sustainable solutions for their youth and families - which may carve out a pathway of replicable practices that could impact all counties in Ohio. We applaud the commitment of, and progress in, both jurisdictions!
